

Respective responsibilities of the body and the auditor

This smaller authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The smaller authority prepares an annual return in accordance with proper practices which:

- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

Our responsibility is to review the annual return in accordance with guidance issued by the National Audit Office (NAO) on behalf of the Comptroller and Auditor General (see note below). Our work does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and does not provide the same level of assurance that such an audit would do.

External auditor report (ACEX0242)

Except for the matters reported below, on the basis of our review of the annual return, in our opinion the information annual return is in accordance with proper practices and no matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Section 2, Box 9: Information received from the smaller authority indicates that the assets been revalued to current ins value. Please note that proper practice, as specified in the Practitioners' Guide, only requires that assets are recorded a original cost and no adjustment is required until disposal. Where original cost is not known a proxy such as insurance may be used but this value should remain constant throughout the period of ownership and not be revised to reflect c values. Commercial concepts such as depreciation are not appropriate for smaller authorities.
